



2021 Dallas Bachata Festival, COVID-19 VIRUS LIABILITY WAIVER AGREEMENT

I desire to participate in the Dallas Bachata Festival and, in consideration of being allowed to participate in this year festival, I agree as follows:

- I acknowledge I must be an active participant in my own healthcare and that personal responsibility is imperative regarding the COVID-19 virus.
- I agree to follow all Dallas Bachata Festival policies and procedures regarding COVID-19. I understand that I may be removed from the Events if I do not comply with Dallas Bachata Festival policies and procedures.
- I agree to wear a mask in all public spaces including while participating at the Dallas Bachata Festival, practice physical distancing when feasible as much as possible, and frequently wash or sanitize my hands during the 4 days of the Dallas Bachata Festival.
- I will not participate in the Dallas Bachata Festival while I have any of the following symptoms: respiratory symptoms (such as dry cough or shortness of breath), a fever of 100.4 degrees or higher, sore throat, chills, body fatigue or aches, loss of taste or smell, headache, congestion or runny nose, nausea or vomiting, or diarrhea. I understand that COVID-19 is a highly contagious disease, and I may contract COVID-19 even if I follow the safety precautions above. I also understand that, although Dallas Bachata Festival will follow guidance from the CDC and state and local authorities to reduce the spread of COVID-19, Dallas Bachata Festival cannot completely eliminate the risk of individuals participating in the HSD Events from contracting COVID-19. I agree to voluntarily assume all risks related to the COVID-19 virus. I am fully informed or otherwise aware of, and fully assume, all risks to person and property in connection with my participation in the Dallas Bachata Festival, including but not limited to property damage and loss, bodily injuries, sickness, disease, and death.
- I fully RELEASE, WAIVE AND DISCHARGE, and COVENANT NOT TO SUE, Dallas Bachata Festival (including, but not limited to, its directors, advisors, volunteers, staff employees and representatives) from and for any and all demands, claims, actions, suits, damages, losses, liabilities, costs and expenses (including but not limited to court costs and attorneys' fees), from any cause whatsoever (including but not limited to property damage and loss, bodily injuries, sickness, disease and death), directly or indirectly due to the COVID-19 virus, whether or not foreseeable or contributed to by the negligent acts or omissions of Dallas Bachata Festival or others.
- I have read and fully understand this Dallas Bachata Festival Covid-19 Virus Liability Waiver Agreement and intend that this Agreement be legally binding and enforceable upon me and my family, estate, heirs, and legal representatives.
